President's Page

Last May the Brown County Commission voted three to two against recommending to the governor the sale of approximately 145 acres of land near Warner, South Dakota, by its owner, Mr. Jacob Mardian of Aberdeen, to the U.S. Fish and Wildlife Service as a waterfowl production reserve. Some of the commission members claimed that the sale would take the land out of farm crop cultivation. They wanted it sold to a farmer, although it is reported that at



least one-third of the tract is not farmable. Fortunately, Governor Kneip approved the purchase anyway, after receiving a sensible letter from the Brown County Sportsmen's Club. I am sure that this is not the only occasion on which the argu-

ment will be advanced that wetland acquisitions diminish acreage that should be used for farming. Last spring during SDOU's May meeting at Ordway Prairie I heard one of our party on a field trip say that he had heard a farmer complaining that Deer Creek Canyon, which we stopped to explore, was not being utilized as cropland.

These two incidents suggest what is probably a widespread belief that vacant, accessible land should serve only the purposes of agriculture, and I cannot help thinking that it is derived from what scholars call the "agrarian tradition." By this is meant a set of attitudes, thinking habits, and notions (often evident only when extended by inference and difficult to examine) that are very old and are traceable to the beginnings of Western civilization. Together they form a mysti-

que about the sacred character of farming and country life generally. According to this tradition, the land is believed to be God's gift to man which He intended to be tilled. Closely related are the convictions that agriculture is the foundation of civilization and the proper center of a nation's economy because it alone produces real wealth, all other occupations being of secondary importance; that it is the way of life most conducive to virtue and that is produces the best citizens, the most careful quardians of the nation's destiny, and the best soldiers; that the lives of rural peoples-especially those living on the familysized farm--are healthier, happier, wiser, more free from vice than those of urban people; and that country life breeds the spirit of independence. Thomas Jefferson, the chief spokesman for the agrarian tradition in America, said that farmers are "the chosen people of God. if ever He had a chosen people."

Placed in this context of a timehonored tradition that exalts farming and its way of life, the Brown County Commission's negative recommendation to Governor Kneip can be better understood, and we can also anticipate one kind of opposition that the wetland acquisition program is going to face, as well as other programs that allegedly sacrifice farm lands to the ideal of wildlife protection and sustenance and of environment restoration. The problem is similar, of course, to all the others created by modern man's zeal for "development," whether it be the Western public lands that organized cattlemen and sheepmen tried to steal in the 1940's and the early 1950's or the Alaskan wilderness today. -- Bill Lemons. Wildlife Land Acquisitions: How Much Do We Know And Appreciate Them?

When the snow lies deep in the coulees, on the native prairies, and over the wetlands of South Dakota, we look forward to field trips to Sand Lake National Wildlife Refuge (N.W.R.), LaCreek N.W.R., Newton Hills State Park, Sica Hollow State Park, and many other parks and public shooting areas where we will find excellent birding. The Samuel H. Ordway Memorial Prairie, one of the largest projects in which The Nature Conservancy has invested its time and money, was the site for 1978 S.D.O.U. spring field trips. In many of the state and federal public land areas that have been set aside in South Dakota for game production and hunting, nature study groups will find some of the finest natural habitats left in the state or the nation in which to study and photograph wildlife species.

A close look at the records of rare or unusual bird sightings around the state will give one a good idea of the value of these public lands for the study of wildlife. Red-necked Grebes nest regularly in South Dakota only at Waubay N.W.R., and the Horned Grebe has recently been found nesting on United States Fish and Wildlife Service (USF&WS) wetlands in Edmunds and McPherson Counties, Trumpeter Swans have been brought back from nearextinction on several USF&WS refuges, including the LaCreek N.W.R. in South Dakota, When S.D.O.U. members set out to find American Woodcocks in courtship display they go to Clay County, Newton Hills, Hartford Beach or Sica Hollow State Parks, or to Public Shooting Areas (PSA) in Deuel County. Only at Sica Hollow State Park, in western Roberts County, may we count on finding Cooper's Hawks, Broad-

winged Hawks, Ruby-throated Hummingbirds, and Veeries during the breeding season. The Whip-poor-will, Brown Creeper, Wood Thrush, Blackand-white Warbler, and Ovenbird are found during the summer months only along the Missouri River, in undisturbed forest lands. In eastern South Dakota these species may be found on Farm Island near Pierre, in Clay County State Park, and in the one remaining stretch of undisturbed Missouri River habitat in the Greenwood area in Charles Mix County. If we are fortunate we will again have the Bald Eagles nesting in South Dakota, and it is likely that they will establish breeding territories on the new eagle refuge, recently purchased by the USF&WS, which is south of Pickstown in Charles Mix County. Some other examples are Sprague's Pipits on the Fort Pierre National Grasslands and Samuel H. Ordway Memorial Prairie, Baird's Sparrows on USF&WS Waterfowl Production Areas (WPA) in Edmunds and McPherson Counties, Snowy and Cattle Egrets nesting at Sand Lake N.W.R., King Rails at LaCreek N.W.R., plus warbler waves and shorebird concentrations in the spring and fall at many PSA's in eastern South Dakota.

It is no coincidence that these bird species are found at the above locations. They are there because their preferred habitats -- woodlands, wetlands, native prairies, or brushy draws -- are at those sites, undisturbed by livestock, haying operations, or cross-country travel by vehicles. This, of course, is the prime reason for wildlife land acquisition programs, and we can take pride in knowing that the South Dakota Department of Wildlife, Parks and Forestry (WP&F) was one of the first state departments in the

nation to emphasize the acquisition of such lands on a large scale, and it has continued over the years to do a fine job of protecting these areas. Similar programs have been adopted by the USF&WS and, more recently, The Nature Conservancy.

I was somewhat surprised and disappointed to find that there has not been more awareness of these acquisition programs by S.D.O.U. members and other nature study groups. Except for The Nature Conservancy, the agencies that purchase wildlife lands in South Dakota have a major responsibility to hunters since the money for the purchase of PSA's and WPA's comes from the excise tax on the sale of hunting supplies and equipment and from the sale of hunting licenses. I can assure you that active hunters know exactly where all of the shooting areas are located in their counties, and they are often guite vocal and concerned about the management of those areas. But how many S.D.O.U. members know these locations, the land they encompass, and the wildlife species that use them?

Local hunters and neighboring landowners are aware of the many problems we face in the management and preservation of these areas. How many members of S.D.O.U. or of other groups interested in natural history have the same awareness? Because of the high price of land and the high priorities placed upon the use of all lands, we are approaching some very critical times when increased pressures will be placed on agencies that want to preserve native habitat. These agencies need all possible support and public interest if they are going to retain the lands they have acquired, to say nothing of being able to continue their land acquisition programs. If you value the lands I have described you will be appalled at the idea of those lands being sold at public auction and returned to private ownership. But this is exactly the situation that

is now facing WP&F as a result of continual public pressure and severe budget problems. I have heard knowledgeable local people say they think that it is just a matter of time before these pressures will force the sale of some PSA's in South Dakota. Some of the pressures stem from a prevailing belief in the agricultural community that land is being wasted if it is not producing crops, ópposition to government ownership of any land, and misunderstanding of management practises. Increased land prices and taxes have become additional problems.

The first objective of the USF&WS has been the preservation of habitat for waterfowl production, with the secondary objective being public shooting areas. Three problems now confronting the USF&WS are: (1) weed control, (2) a public that is misinformed about the payment of taxes on WPA's, (3) the requirement that any USF&WS purchase must be approved by County Commissions. Weed control is expensive and timeconsuming and any success depends on available monies and manpower. The second problem resulted from federal restrictions on payment of local taxes, leaving the public with the impression that no taxes are paid on WPA lands. The USF&WS makes "revenue sharing" payments to the counties in lieu of taxes, and these payments are comparable to the taxes paid by the former landowner. In 1976 the payments totaled \$138,441.00 to South Dakota counties. The requirement in the third problem is making it increasingly difficult for the USF&WS to acquire wetlands. An agreement signed many years ago between the USF&WS and several states, including South Dakota, makes it necesary for the USF&WS to get authorization from County Commissions before purchasing any wetlands (even from willing sellers) in their particular counties, thus making it possible for county commissioners, as agents of the governor, to

refuse to allow a USF&WS land purchase. This arrangement apparently brought no special problems until recent years when land prices and taxes spiralled upwards. As a result, some County Commissions will not approve the sale of lands to USF&WS because local township boards do not want to have the lands taken off the tax rolls. The USF&WS has the right to present its case to the governor for review, but this is not often done because of the public relation realities.

There are many ways that S.D.O.U. members can help these agencies in the acquisition and management of wildlife lands. You must first become familiar with the wildlife areas in your county and in other parts of the state. Get out on these areas regularly, and if it is necessary, report trespass or other violations to your local Conservation Officer (CO). If you know of a suitable tract that might be purchased by the WP&F, the USF&WS, or The Nature Conservancy, contact someone who can get the information to the proper organization. The CO is often the most available person. You can also lend your support in any way that will make it easier for the USF&WS to purchase land in your area without obtaining authorization from the county commission. Possibly a review of the standing agreement between the agencies involved might be the answer to this problem. But the first and most important way you can help is to become informed about the public land programs and the land areas in the state. A group that is so dependent on public lands, as S.D.O.U. is, cannot afford to do anything less than this at the present time. -- Clear Lake, SD.

SPRING MEETING

The South Dakota Ornithologists' Union and The Nature Conservancy held a joint meeting at the Samuel H. Ordway Memorial Prairie, May 19-21, 1978, with hosts Paul and Susan Bultsma, whose gracious hospitality will be remembered with much pleasure. The site for the meeting, customarily referred to as Ordway Prairie, is in McPherson County; its 7600 acres make up one of the four projects purchased in South Dakota by The Nature Conservancy.

As part of the Friday evening program Paul Bultsma, manager, gave a description of Ordway Prairie and told about some of the management practises that will eventually return the land to its native state. Cattle grazing through May is one of the methods being used to eliminate introduced plant species, particularly cool season grasses. The buffalo, along with other animal species, will again be seen on Ordway Prairie as they were in earlier years. The project is a laboratory for students and researchers who also assist with the work.

Grace Lieberman, Field Representative from The Nature Conservancy Midwest Regional Office, Minneapolis, told about the organization's **aims in** acquiring and preserving lands of special ecological value. Ordway Prairie is a fine example of the application of their program. David Holden, representing The Nature Conservancy, then used some superb slides for an illustrated talk entitled "Our Prairie Heritage."

On Saturday the field trip participants could take the hay rack ride around Ordway Prairie or go by car caravan to pot hole areas and Sand Lake National Wildlife Refuge. Leaders included Paul Bultsma, John T. Lokemoen, and Harold Duebbert, Noteworthy finds during the trips were three active Horned Grebe nests and two Ferruginous Hawk nests. There was good attendance later at the delicious banquet served by members of the St. James Lutheran Church in the nearby town of Leola. In the preliminary part of the program Bruce Harris gave a summary of wetlands and wildlife lands programs in South Dakota. His paper on the subject is in this issue of Bird Notes. Dr. Dilwyn Rogers discussed The Nature Conservancy, and Grace Lieberman presented two awards: David Holden received The Nature Conservancy Award for his 15 years of work for the organization in South Dakota, and Dr. Rogers was recognized for his efforts which were directly responsible for an increase in membership in the South Dakota chapter of The Nature Conservancy. The main event of the program was an illustrated talk entitled "Distribution and Densities of Waterfowl and Shorebird Nests on an Island in Miller Lake," which was presented by John T. Lokemoen and Harold Duebbert of the Northern Prairie Wildlife Research Center, Jamestown, North Dakota. In their studies of the island Lokemoen and Duebbert found that the ducks had several hundred predator-free, successful nests per acre. whereas the normal distribution is about four nests per acre. The density on the island is a natural condition but it suggests the possibility that it can be a model for artificial islands and management programs that will maintain or increase waterfowl production. This talk was followed with interest and appreciation, and we hope that a summary will be submitted for publication in Bird Notes.

Participants on the Sunday morning field trips returned to the headquarters

at Ordway Prairie for a buffalo barbecue luncheon. This was followed by the species check-off, which included birds observed during field trips across the state line into North Dakota, in McPherson and Brown Counties, and on Ordway Prairie. Among the subsequent announcements was one for a summer field trip to be held at Pierre in July.

General Notes of Special Interest

YOUNG SAW-WHET OWLS IN ROBERTS COUNTY - In the late afternoon of May 29, 1978, I glanced out the window of our cabin at Big Stone Lake in Roberts County, about one-half mile from the Grant County line, and noticed a small, lovely brown furry object in the grass a few feet beyond our patio. I called the attention of my husband Earl to this furry little ball, thinking it was perhaps a small animal. We watched it a few minutes. then went out on the patio and the little animal turned its head to look at us. To our surprise it was a cute little owl with large white-encircled eves and a white crescent on top of its head. It flew to a branch of a nearby tree where we observed it for a while. It had moved by the next morning but it was still in front of our cabin.

Later that day, May 30, I was looking for a robin's nest in our evergreen trees and I thought I had found one, but upon looking closer I discovered that it was another owl. This was a larger bird with lighter-colored feathers, but it had the same white markings on the head and around the eyes. It did not appear to be frightened and I continued to watch it at intervals for the rest of the day. It was gone the next morning.

A few days later Earl was clipping the hedge and again saw our little bird. It flew to a tree branch where it was immediately attacked by robins and blackbirds and knocked to the ground. It took refuge between the tree and a log. Perhaps I could have picked it up but I did not try. In another few days the owl was on the roof of our cabin where it was again attacked by other birds.

About dusk we could hear these birds calling "pssst, psst," and we knew they were nearby. The last evening we saw the little owls was about June 14. Their continued "pssst" call directed us to their location on a branch in front of our cabin where we saw *three* owls. I am sure that they were two young and an adult. Attempts to photograph them were unsuccessful. We checked our *Birds of North America* and identified them as Saw-whet Owls. Other observers of the owls were Mr. and Mrs. James Cole, Lloyd Jones, and Don Weber.

We reported our observations to Bruce K. Harris, Conservation Officer, Clear Lake, and he informed us that the Saw-whet Owl is a rare species in this area. -- Kathleen and Earl Spinner, Clear Lake.

Editor's Note: Bruce K. Harris stated in correspondence that James Cole, resident of Gary, Deuel Co., had described the little owls to him as being so dark in coloration that he at first thought they were small animals on the lawn. Harris commented that this agrees with the literature on the species.

CLIFF SWALLOW BEHAVIOR IN DAY COUNTY -- In late spring, 1977, I found it necessary to move an old school house that I had been using for a granary. While getting it ready I noticed that two pairs of swallows were building nests under the eaves. These birds did not have the forked tails and rust-colored breasts of the Barn Swallows so I checked their markings with my bird guide and found that they were Cliff Swallows. Being a bird lover, I was unhappy about moving their half-built homes, but it had to be done.

By a roundabout route we moved the building to a field location that was a little over two and one-half miles in a

straight line from the original position. When I next saw the building three days later, I found both pairs of swallows busily completing their jug-shaped nests. The color of the mud in the two stages of building showed distinctly where the birds had been interrupted. They raised two families.

Did the birds follow the building or go scouting for a new location and find it? (Were they the same birds? -- Ed.) Since we did not expect the swallows to follow the moving building, we did not watch for them or see them. -- Virgil Sikkink, Waubay.

Persons licensed to band birds as unpaid volunteers in cooperation with the Fish and Wildlife Service are bound by the very strict rules of the Bird Banding Laboratory. In **South Dakota Bird Notes** Vol. 29 No. 4, December, 1977, P. 70 three changes were made in the data which we submitted, titled Banding Summary, Oakwood Lakes State Park.

Somewhere in the editing process our "Traill's Flycatcher - 48" became "Willow Flycatcher - 48." We are well aware of the splitting by the AOU of the "Traill's" species into "Willow" and "Alder." However, we followed directive MTAB - 2 --06-26-73 -- Section 1-f in using the "Traill's" designation. In addition many of these birds were banded before the splitting occurred.

Bird number 70 in the list, "Northern Oriole - 37" should have been followed by "(Baltimore)" "MTAB - 21 -- 06-26-73 --Section 1-K.

Bird number 80 in the list, "Dark-eyed Junco (Slate-col.)" should have read, "Northern Junco (Slate-colored)." MTAB - 21 -- 06-26-73 -- Selection 1-). states specifically, "---do not use 'Dark-eyed Junco' on Schedules."

SPRING MIGRATION REPORT

March 1 - May 31, 1978 Compilers: G.L. Steffen, B.K. Harris, J. Harter

Late, cool, and wet describes the spring season, and the Black Hills received additional snow in mid-May. Snow runoff filled wetlands, ponds, and lakes over the state; these water levels remained excellent even though precipitation totals fell below normal in eastern areas by the end of the period.

The large numbers of waterfowl had plenty of habitat to meet their needs, but populations of most species of shorebirds were noticeably low because of water-covered habitat.

Spring 1978 was not without its highlights: nesting Horned Grebes, Little Blue Heron, White-faced Ibis, Snowy Egrets, Peregrine Falcons, numerous Short-eared Owls, Black-backed Threetoed Woodpecker, Carolina Wren, Bluegray Gnatcatcher, male Hooded Warbler, and the singing Baird's Sparrows observed in several areas.
